An appealing parcel of grazing/fodder grassland which forms an irregular shaped parcel of land, anticipated to be of significant agricultural, conservation and amenity interest. The land is situated in an excellent location and tranquil situation within the Monnow Valley, a short distance from the Welsh Border town of Monmouth.

The land has potential to be sub divided further if required into a number of paddocks for agricultural or equestrian use.

Monmouth - 4.5 miles • Skenfrith - 2.5 miles Ross-on-Wye - 12 miles

Location & Situation

The land is well located within the beautiful Monnow Valley a short distance outside of the hamlet of St Maughans to the west of the St Maughans to Skenfrith Lane. The land shares an access with an entrance to Farr Barn. There are beautiful views to the east, especially from the elevated parts of the land.

Description

The land at St Maughans is accessed via a short track set back from the St Maughans to Skenfrith Lane and forms an appealing irregular shaped parcel of grazing/fodder grassland, divided into two principal enclosures. The land is gentle undulating, and has potential to be sub divided further into a series of paddocks if required.

There are several pockets of woodland copses, with a small pond situated at the southern end of the land, and meandering stream bordering the north, which will provide for additional amenity/ conservation interest. There are mature hedgerows around the field boundary which also join the plantation of deciduous woodland to the west a small brick former pump house still exists on the edge of the western field parcel.

In all the land extends to approximately 7.94 hectares (19.62 acres).

Services


There are no mains services directly connected to the Land. Interested parties are to make and rely on their own enquiries in respect of any connection to mains services.
