### Woodland at Dan-Y-Graig

The Woodland at Dan-Y-Graig provides a desirable parcel of mature broadleaf woodland. Having previously been managed with ecological protection as a priority. The woodland will be of interest to purchasers with a conservation or amenity interest.

#### **Location & Situation**

The woodland is positioned overlooking the town of Risca on the slopes of Mynydd Machen. Located within the wider woodland known as Dan-Y-Graig the property provides excellent amenity appeal.

Access is by foot only, directly from the footpath leading from Tir-y-Cwm Lane.

#### Description

Part of a much larger expanse of woodland overlooking Risca. Dan-Y-Graig Wood is dominated by ash, sycamore and oak trees. There is a small pond which provides excellent amenity and conservation benefits to the Property.

Much of the woodland is sloping, but, with a number of pathways providing the ability to explore the woodland and all it has to offer with ease. The purchaser will be responsible for all boundary fencing as per the existing marker posts..


Extending in total to approximately 0.70 acre.

#### **Directions**

Driving towards Risca from the B4591. At the roundabout where the B4591 heads west towards Risca railway station, take the second exit onto Commercial Road, leading through Risca town centre. Shortly after passing the Baptist Church on your right, turn left down Dan-y-Graig Road. Follow the road as it passes under the A467 and bear right past the row of bungalows. Cars can be parked on the road outside the brickworks.

Continue to the Property on foot by walking back down Dan-y-Graig Road and then take the first right onto Tir y Cwm Lane. Walk about 50m up the hill and the sloped path up to the gated Property entrance is on your right.
