# Land known as Pren-Y-Derwen, Gwehelog, Usk, Monmouthshire, NP15 1RJ

An appealing parcel of permanent pasture grazing field with two compact paddocks and grazing fields, which forms a compact irregular shaped parcel of land situated in a tranquil area surrounded by deciduous woodland.

The land has direct access from the Old Raglan/Usk Road a short distance from the hamlet of Gwehelog and riverside town of Usk.

Gwehelog - 0.5 miles Usk - 1.5 miles Raglan - 4.0 miles Newport – 11.5 miles

## **Location & Situation**

The land is well located in the Usk Valley a short distance from the renowned river side town of Usk. The land enjoys a private position in a tranquil setting, with deciduous woodland bordering nearly all of the land.

## Description

The land comprises a compact irregular shaped parcel of permanent pasture land which has a gently sloping roadside paddock, through to more steeply sloping pasture grazing fields with some more elevated level areas.

A stone access track runs through the first small paddock which provides good access to the top of the second and third fields. There is an area of hardstanding at the top of the central third field. There are several specimen oak trees amongst the grazing fields.

A small woodland copse of deciduous trees lies adjacent to the western boundary, along with small spring, which adds to the conservation and amenity appeal of the land. In all the land extends to approximately 5.09 hectares

(12.59 acres).

#### Services

Mains water is directly connected to the land. Interested parties are to make their own enquiries in respect of any mains water supply.
