### Land at Talycoed Lane

Llantilio Crossenny, Abergavenny, Monmouthshire, NP7 8TL

An appealing grazing pasture field which forms a compact regular shaped parcel of land, situated in central Monmouthshire, in a tranquil area and with easy access to the B4233 between Abergavenny and Monmouth.

The land has potential to be sub divided into a number of paddocks for agricultural or equestrian use.

Llantilio Crossenny - 1.5 miles Monmouth - 7.0 miles Abergavenny - 7.8 miles Raglan - 8.5 miles

### **Location & Situation**

The land is well located in the area of Talycoed a short distance north of the B4233 between Abergavenny and Monmouth. The land benefits from direct access from Talycoed Lane, and enjoys a tranquil setting, with deciduous woodland bordering the land to the west and views to the south.

### Description

The land comprises a compact regular shaped parcel of permanent pasture land which is gently sloping to the south aspect.


The land benefits from independent field gate access direct from the Talycoed Lane, opposite Talycoed Farm entrance.

The land offers an excellent agricultural or equestrian field, or for utilisation for recreational uses (subject to any necessary consents). The field has potential to be sub-divided if necessary.

In all the land extends to approximately 2.64 hectares (6.52 acres).
