Location & Situation

The site is situated adjacent to an unclassified council lane connecting to the B4221, which runs between Gorsley and Upton Bishop. Junction 3 of the M50 is very close by, with the site being situated directly to the north of the M50.

Description

The site comprises of a mainly level, tapering storage yard site, adjacent to the north side of the M50. An earth bund and hedge divides the site from the council highway. The site has formerly been used as a Highways contractor's yard and is vacant apart from some piles of aggregate. A hard surface base of stone or tarmac is laid throughout, with a small area of trees on the western boundary.

The site extends to approximately 0.44 acres (0.176 hectares).

Services

There are no mains services directly connected to the land that the vendors are aware of. It is for any interested party to investigate and satisfy themselves on the ability to connect to any services they require.

Take the next left turn after a very short distance signposted 'Linton'. Continue on this unclassified council lane the site is within 0.5 mile on the left hand side.
